Tribute to Roberta (Bobbie) Byrnes Czarsty

Roberta Czarsty was a member of the Foundation for many years, serving on the Board of Trustees and as President from 1987 through 1989. Bobbie chaired the student Loan Fund and guided its change to the student Scholarship Fund which she then chaired for over twenty years.



Bobbie was very active in a variety of charities and foundations as well as supporting her husband's work in organized medicine. She was President of the Waterbury Hospital Auxiliary and one of its first life members and

a former incorporator of the Hospital. She originated the Auxiliary's annual Christmas greeting in the Waterbury Republican. She was the President of the Auxiliaries of the Waterbury Medical Association, New Haven County, Litchfield County and Connecticut State Medical Societies. She was the Eastern Regional Representative to the Board of Directors of the Auxiliary of the American Medical Association. For many years, she was the Editor of the Connecticut State Medical Society Auxiliary's newspaper. She and her husband started a scholarship fund at the Connecticut Academy of Family Physicians to support medical students interested in family medicine. The fund was later named for them.

Bobbie was on the Board of Directors of the Watertown Library Association and also the Clockwork Repertory Theatre. We remember her today mostly for her dedication to the Watertown Foundation.

Roberta Czarsty's philanthropy throughout her life is a model for us all. Her commitment to health care, education, professional support organizations, and her community foundation, the Watertown Foundation, shall long be remembered.

Roberta Czarsty died in September, 2009 after a long illness. She was predeceased by her husband Joseph C. Czarsty, M.D.

I thank the trustees for the time and energy they volunteer in guiding this organization. I thank longtime trustee and past president, Richard Wick who will leave our board this year. He has devoted countless hours to our foundation. We will miss his counsel. I thank all of you for your generosity and welcome your future support and involvement. We can do what we do because of your commitment to your foundation. Together, for 85 years, we are *Connecting our Community through Giving*.

Help continue the Watertown Foundation's legacy of support for the many special qualities that make Watertown an extraordinary community. Membership in the Watertown Foundation is open to the public. The contribution for membership is \$200, payable in four annual installments of \$50 or one \$200 payment.

A donor may support the Foundation's continuing work with an unrestricted gift of any amount. Our donors are individuals, families, businesses, and charitable organizations. Donors may give cash, stock, retirement assets, bequests and other planned gifts.

Designating the Watertown Foundation as the recipient of a *Memorial Donation* continues the memory and spirit of a deceased family member or friend. *In Honor Of* gifts for living relatives or friends in lieu of holiday or birthday gifts can celebrate the event in a meaningful way. *Memorial Donations* and *In Honor Of* donations are received throughout the year. Acknowledgement is sent to the donor and a complete listing of gifts is sent to the family or party.

The Foundation's assets are professionally managed with oversight by the Finance Committee and Board of Trustees. There is no cost to establish a Trust Fund. Simply complete the information requested on the membership contribution envelope and mail with your tax-deductible

membership check directly to the Watertown Foundation, P.O. Box 117, Watertown, CT 06795. A confirmation of your gift will be mailed to you.

Trust Funds

A Trust Fund in the Watertown Foundation provides the opportunity for individuals or corporations to provide a permanent legacy in our community. Trust Funds create permanent endowment funds that steadily grow in value over time and produce income for academic scholarships to individuals and grants to local charitable nonprofit organizations.

The Foundation requires a minimum of \$5,000 to establish a Trust Fund. This gift may be given as a lump sum or over a period of five years. Donors may also leave charitable assets upon their death in the form of a bequest in a will or trust, retirement plan designations, or beneficiary designation in a life insurance policy.

The Watertown Foundation will create a special fund in your name, in the name of your family or business, or in honor of any person or organization you choose. You receive tax benefits in the year your gift is made. Your gift will be placed into an endowment fund that is invested over time, and earnings from the fund are used to make grants addressing community needs. Your gift, and all future earnings from your gift, will provide support for scholarships

and organizations helping people and programs in perpetuity.

Distribution from Named Trust Funds

Each year the Board of Trustees establishes the amounts to be awarded in scholarships and grants, based on the endowment's market value and the success of its investments. This distribution policy strives to maintain the "purchasing power" of the funds over the long term to protect against inflation so that today's assets are not diminished in the future. The Board does not assess fees in the administration of Trust Funds or in the awarding of grants or scholarships.

Types of Funds

Unrestricted

The principal of an unrestricted fund is invested and retained by the Watertown Foundation. Income from investments is pooled and is awarded annually to nonprofit community organizations by the Board of Trustees. An unrestricted fund provides the most flexibility to the Board to meet needs in our community.

Field Of Interest

A Trust Fund may specify a particular field of interest such as the arts, youth athletics, education, social service, or the environment with a minimum gift of \$50,000. The Board of Trustees selects projects within your field of interest and presents the award in the name of the Trust Fund.

Scholarships

Named scholarships may be created with a minimum gift of \$25,000. Scholarships may be designated for study in broadly defined areas such as medicine and health careers, social service, business, engineering, and education. Criteria for selection are at the discretion of the Board of Trustees and are defined annually in the Watertown Foundation Scholarship Application. Recipients must be Watertown residents.

Tax-free contributions

The Watertown Foundation is a public charity. Donations to the foundation qualify for the maximum tax benefit allowable by law.

Scholarships Awarded For 2011

The Watertown Foundation provides scholarships to graduating high school seniors to assist them financially in achieving post-secondary education. Scholarship awards are competitive and are based on information submitted on the application and the high school scholastic record, test scores, essays, extracurricular and community involvement, and financial information. Awards are the sole decision and responsibility of the Watertown Foundation Scholarship Committee and are based on the committee judgment of the applicant's submitted application information. Application criteria include: residency in Oakville-Watertown for at least three years (regardless of the secondary school attended); academic merit, contributions to the applicant's school and community, and financial need.

Reinhold and Katie DeWitt Scholarship - \$2,000

Awarded on the basis of academic excellence, demonstrated sensitivity to the needs of others, and the ability to work cooperatively with those in need. This scholarship is not based on financial need.

Kristen Proe, Taft School, will attend Yale University in pursuit of a degree in political science.

Thomas Baker, Watertown High School, will attend Clark University with an intended major of human services.

Ricky Bozzuto Memorial Scholarship - \$1,000

Awarded to a graduating Watertown High School senior on the basis of academic excellence in the areas of mathematics, physical sciences and information technology. The recipient should have financial need. This scholarship is given in memory of a man devoted to scholarship, country, work, and especially his family.

Joseph M. Favale, Jr., Watertown High School, will attend Roger Williams University with an anticipated major of chemistry.

Fletcher Judson Memorial Scholarship - \$1,000

Awarded to a graduating Watertown High School senior on the basis of academic excellence and exemplary community service.

Matthew Terzigni, Watertown High School, will attend High Point University in North Carolina with an intended major of secondary education.

Guinea Silks Orsillo Scholarship - \$1,000

Awarded to two Watertown High School seniors in the top half of their graduating class, who have financial need, and have participated in Watertown High School's sports programs as players, cheerleaders, or managers. This scholarship is in memory of three Watertown High School students.

Steven Lewis, Watertown High School, will attend the University of Connecticut in Storrs. His intended academic major is sports management.

Nicole Mancinone, Watertown High School, will attend Sacred Heart University with a major of nursing.

Crystal Lukowski Memorial Scholarship - \$1,000

Awarded to a Watertown High School senior intending to pursue a career in health, allied health, or medicine. This scholarship is given in memory of Crystal Lukowski, a special needs student, who graduated from WHS in 1994.

Ashley Petrazzello, Watertown High School, will attend Springfield College in the physician assistant program.

Marigold Spencer Memorial Scholarship - \$1,000

Awarded to a Watertown High School senior who has contributed to the community through generous use of time, talents, and leadership. This scholarship is given in memory of a long-time Watertown resident who lived this same spirit of generosity.
